Bylaws for the use of Compound Screening System

(Purpose)

Article 1 These bylaws are to establish necessary items for the use of Compound Screening System(afterward: System) which Center for Research and Education on Drug Discovery, Faculty of Pharmaceutical Sciences, Hokkaido University, National University Corporation(afterward: Center) manages and utilizes.

(Purpose of Use)

Article 2 System can be used to construct innovative drug discovery process which can connect academic study or renew drug discovery / medical skill seeze with drug production firmly and immediately.

However, when the Director of Center for Research and Education on Drug Discovery, Faculty of Pharmaceutical Sciences, Hokkaido University, National University Corporation(afterward: Director) admit it to be an appropriate purpose, the person or the research is allowed to use the Center educationally on the condition that the experiment causes no obstacles for the Center.

(Qualification for user)

Article 3 The person who is able to use the Center should fulfill any requirement of them below.

- (1) The staff or researcher working for Hokkaido University, National University corporation
- (2) The researcher working for domestic public Institution
- (3) The researcher working for domestic private Institution
- (4) The person chief admit appropriate

(application for the use)

Article 4 The person who will use the Center is obliged to apply for the Director by the application form of the Center own and to be accepted the use.

Also, when you use Tokyo University innovation center compound library

(afterward: Todai Drug Discovery) , you have to follow the same procedure.

However individual usage of Todai Drug Discovery isn't adapted to this rule.

(Approval of the use)

Article 5 In case that Director accept the application in previous article, the applicant would be admitted when Director approves the use as an adequate one.

(Change of the usage)

Article 6 The person who has been given an approval of the use of the Center (Afterward: User) should notify any change to Director immediately if something has differed about the content of application.

(Prohibition of other purpose than application)

Article 7 The user is not permitted to use Center in other purpose deviated from the applied one and also to let others use the Center.

(Cancellation of the acceptance of the use and others)

Article 9 Director has authority to cancel the article 5 and make it stop using when the user is against the bylaws and causes the severe damage on the system.

(Charge)

Article 10 Basically it is followed by the contract with Today Drug Discovery.

The use of compound screening devices which belong to Center is free of charge.

The consumables other than compound library required in screening are regarded as actual expense. But what was carried in is counted as charge-free.

However, when Director admit it, there is a possibility that the expense would be reduced. You can contact with Center if you have any questions.

(Compensation for damage)

Article 11 User should have obligation of the compensation for damage when he or she gave damage to facilities on purpose or by severe fault.

(Office)

Article 12 The office work connected with the use of the system is coped with by Center.

(Miscellaneous regulations)

Article 13 Some other articles necessary for the use of the system are set by Director apart from these bylaws through the Center managing council.

Paragraph

This bylaw comes in effect from December 23, 2011.

This bylaw comes in effect from September 27, 2012.
